## BSL puts onus on wood fuel suppliers



After concerns that treated waste wood containing elevated concentrations of copper, chromium and arsenic is being distributed in wood-fuel supply chains, including

the RHI supply chain, the BSL has put the onus back onto wood fuel suppliers.

They are stating that burning treated waste wood as a fuel is **subject to waste management controls** and must only be done under an appropriate permit. **Supplying or burning waste derived woodfuel in an unauthorized combustion plant is an offence.**

Unauthorised boilers and other combustion plants burning waste derived woodfuel are unlikely to meet the manufacturer's operating instructions, nor will these plants have adequate control systems on emissions.



Renewable Heat Incentive payments may be withdrawn where participants use fuel that is not specified on their boiler's emissions certificate.

If you manage waste wood, please review your procedures and ensure that your customer (i.e. the person purchasing your processed waste wood) holds an appropriate permit that authorises them to burn waste wood or has registered an exemption and is complying with the terms and conditions of that exemption.

They state that **"You have a Duty of Care to do this and may commit an offence if you don't."**

# Mega Watt Installer Partner Programme

During February, we successfully launched our partnership with Eurobiomass Polska, part of Leroux and Lotz Technologies, which now enables us to supply fully automatic boilers ranging from 200kW up to 15MW in capacity, all fired by a variety of biomass and waste with different sizes and humidity.

## RHI Update

From March 2017, the following changes to the RHI will take place:

- **Drying digestate** for biogas plants will no longer be eligible for RHI support.
- Under '**Eligible Heat Use**' the government will not be making any immediate changes however they will be reviewing whether wood fuel drying should remain as an eligible heat use.
- **Planning Permission** will be required for all new plant, as well as additional capacity added to existing plant, in order to be eligible for support through the non domestic RHI.
- Following consultation, the reforms will not amend the current rules governing **additional capacity**.
- **Effective Dates**—In general, the changes described above will come into force on the date the regulations come into force and will only be applicable to participants with a tariff start date on, or after that date.

## Consultation on reducing emissions from Medium Combustion Plants and Generators to improve air quality

This recent consultation by the Department for Environment, Food & Rural Affairs seeks views on proposals designed to reduce emissions of harmful air pollutants from medium sized combustion plants in England and Wales.

Operators are required to monitor pollutant emissions periodically. The below plant monitoring frequencies should be interpreted as the minimum requirement:

Type of Plant	Pollutants Monitored	Plant Capacity	Minimum Frequency
natural gas fired plants	Carbon monoxide (CO) and NO <sub>x</sub> emissions	1-20 MWth	Every 3 years
		20-50 MWth	Annually
plants firing gaseous fuels other than natural gas	CO, NO <sub>x</sub> and SO <sub>2</sub> emissions	1-20 MWth	Every 3 years
		20-50 MWth	Annually
plants firing solid and other liquid fuels	CO, NO <sub>x</sub> , SO <sub>2</sub> and PM emissions	1-20 MWth	Every 3 years
		20-50 MWth	Annually
biomass and other solid fuels (operating <500 hours per annum)	CO and PM emissions	1-20 MWth	Every 1,500h of operation, and at least once every 5 years
		20-50 MWth	Every 500h of operation, and at least once every 5 years
gaseous and liquid fuels (operating <500 hours per annum)	CO emissions	1-20 MWth	Every 1,500h of operation, and at least once every 5 years
		20-50 MWth	Every 500h of operation, and at least once every 5 years*
